# LAND PARCEL @ TAMPINES NORTH DRIVE 5





The land parcel is strategically located near Changi Airport and well-established industrial parks at Tampines and Changi South, which are now home to a host of global businesses. Close proximity to Tampines and Pasir Ris New Towns provide a ready pool of labour supply for this site.



The land parcel is highly accessible from Tampines Expressway, Pan-Island Expressway and major arterial roads, providing seamless connectivity to other parts of the island. It is also well-served by Tampines and Pasir Ris MRT stations. Commuters also enjoy the convenience of three Downtown Line stations, which opened in October 2017.

#### 2. Submission of Tender

All tenders must be deposited:

- (b) by 25 October 2022 (Tuesday) before 11:00 am

Any tender submitted after 11:00 am on the tender submission date will not be considered.

#### 3. Tender Deposit

Every tenderer shall pay a tender deposit of at least five percent (5%) of the tendered sale price.

The tender deposit mentioned in Condition 12 of the Conditions of Tender ("Tender Deposit") may be paid by any one or more of the following methods:

- (a) Bank Transfer
- (b) Bank Guarantee
- (c) Insurance Guarantee

Payment in CASH or by CHEQUE or any other means WILL NOT BE ACCEPTED. Please refer to the Conditions of Tender for detailed requirement.

The Tender Deposit will be returned to all unsuccessful tenderers.

The Tender Deposit shall be forfeited if the tenderer withdraws his tender during the Tender Validity Period.

Tenders submitted without the Tender Deposit will be disqualified.

## 4. Acceptance of Tender

Tenders shall remain valid for acceptance for ten (10) weeks from the said date of submission of tenders. However, JTC may by notice in writing to each tenderer extend the validity period of his tender by such further period not exceeding two (2) weeks.

JTC reserves the right to reject the highest bid price or any tender or any part thereof.

# 5. Payment of Sale Price

The Successful Tenderer shall pay the bid sale price as follows:-

- (a) 25% (less the Tender Deposit)
- and GST on 25% of the bid sale price within twentyeight (28) days from the date of JTC's acceptance of this tender; and the 28 days shall include the date of JTC's acceptance.
- (b) 75% and the GST thereon within ninety (90) days of acceptance of this tender; and the 90 days shall include the date of JTC's acceptance.
