# HOUSE RULES (KAMPONG UBI)

The following House Rules are deemed to be incorporated in the Terms and Conditions of the Tenancy Agreement. Any infringement to the House Rules shall constitute a breach of the Tenancy Agreement.

## 1 Parking Facilities

- a) The parking facilities are under the management of a car park operator. Tenants/lessees shall liaise directly with the operator on the purchase of season parking tickets and other related car park matters.
- b) Vehicles shall be parked within designated lots and tenants/lessees are refrained from parking along the driveway or common area.

## 2. Loading & Unloading Bay

Loading and Unloading bays are restricted to loading and unloading activities only.

## 3 Common Areas

- a) For ease of access along the common areas, construction of fixtures (either temporary or permanent) is not allowed unless prior written approval from JTC has been obtained.
- b) Common areas especially corridors, lift lobbies, staircases, etc. which are used as emergency escape routes, shall be free of obstruction at all times.
- c) No sleeping or having meals along the common areas.
- d) Smoking is prohibited along the common areas except at designated locations.
- e) All trade effluent and sullage water shall not be discharged into the scupper drains, rain water downpipes / compound or perimeter drains.
- f) The Fire Engine hard-standing areas and access way must be kept free of obstruction at all times.
- g) Only usage of battery operated forklift is allowed. Any use of forklift, including parking should not cause any obstruction or inconvenience to others.

## 4 Internal Premises

- a) Tenants/lessees are fully responsible for the security and maintenance of their premises.
- b) Tenants/lessees must maintain proper control measures / facilities to prevent noise, air pollution or causing nuisance to the neighbouring premises and surroundings.
- c) The fire access panel within the premises where the signage indicates "Fire Fighting Access" shall not be removed/ obstructed.
- d) The fire escape route of 1.2m shall be maintained / fire extinguishers shall be free of obstruction at all times.
- e) Tenants /lessees shall not carry out any trade paraphernalia that will cause obstruction and safety to road users. All approved trade activities must be confined within the premises at all times.

# 5. Canopy & Parapet Wall

Tenants/lessees shall not place paraphernalia on the canopy or on top of the parapet wall.

# HOUSE RULES (KAMPONG UBI)

## 6 Discharge of Air-Conditioner Condensation Water

Condensation water shall be properly discharged to an existing floor trap within the premise.

#### 7 Transportation of Goods and Machines

- a) Goods must be transported via the passenger lifts only.
- b) Shifting of heavy machineries into units for production purposes shall <u>only be</u> carried out with prior approval in writing from JTC.

### 8 Company Signboard / Advertisement

Tenants/lessees shall maintain company signboards only at designated location(s).

### 9 Display of Advertisements

The Tenants/lessees shall keep window glass panes, fencing and common areas free of advertisement signages, banners and posters. Prior written approval must be obtained for all signages at building facades. Temporary Occupation Licence fee will be payable, if approval is granted.

#### 10 Tapping of Electrical / Water Supply from Common Area

Tapping of electricity and water supply from the common area is strictly prohibited unless prior written approval has been obtained from JTC.

#### 11 Unauthorized Use of Fire Hose reel

The fire hose reel shall be used for fire fighting purposes only. To refrain from unauthorized use of water supply from fire hose reel for other purposes. Repair of damage due to misuse will be chargeable to tenant concerned.

### 12 Trade / Domestic Wastes

- a) Tenants/lessees are responsible for making their own arrangement for the disposal of all refuse.
- b) The tenants/lessees shall use refuse bins fitted with enclosed covers and are non leakage type for disposal of trade refuse / wastes. The refuse bins shall be in good working conditions at all times.
- c) Disposal of refuse or trade waste at the common areas, staircases, carpark or driveway is strictly prohibited.

## 13 Pets

Tenants/lessees shall refrain from keeping pets (dogs, cats, birds, etc) within the premises or at the common areas.

## 14 Burning of Incense Paper

There shall be no burning of incense paper at common areas or turf areas. Burning of incense paper is allowed only at designated locations.

# 15 Handicap / Public Toilets

No bathing is allowed in the public toilets.

## 16 Illegal Use of Industrial Premises as Workers' Quarters /Unauthorized Activity

Tenants/lessees shall not permit any person or persons to cook, sleep and/or reside in the premises. Other activity that is commercial in nature or non-motor repair/auto-service is not permitted within the premises.
