The JTC Customer Service Portal (CSP) will enable you to transact with us online from the comfort of your office or home. You will have access to a comprehensive suite of e-services catered to your business needs:

PROPERTY-RELATED INFORMATION

• View information such as property details, application status and statement of account

PROPERTY SEARCH & APPLICATION

• Search and apply for available JTC properties such as flatted factory, ramp-up factory, standard factory and land

LEASE-RELATED TRANSACTIONS

- Access a selection of lease-related transactions:
- Subletting
- Tenancy or lease renewal
- Change of use
- Lease assignment
- Tenancy transfer
- Tenancy termination


GETTING STARTED

Step 1: Set up and assign digital service access to JTC CSP at CorpPass

You will need your CorpPass Administrator for this step.

Go to CorpPass at **www.corppass.gov.sg** and login as an Admin. Select "JTC e-services" as an e-service that you will use.

Assign roles to your CorpPass Users. There are two types of roles - an Approver and a Preparer.



Preparer Partial access as granted by Approver


Step 2: Log in to CSP

Go to **www.jtc.gov.sg** and access CSP under "Customer Services". Click "Log in as Customer" and log in using your CorpPass login and your company's Unique Entity Number (UEN).




Step 3: Complete your profile in CSP

Under "My Profile", fill in your email address and phone number.

Under "Manage Users", you can assign transactional or e-statement roles in CSP to others.


At the CSP homepage, you will see a navigation panel where you can access CSP's e-services, and shortcuts to commonly used functions.

Lease-Related Transactions and e-Statements



- A Under "My Account", you can view your existing property details, and apply for a wide range of lease-related transactions:
 - Subletting (new, renewal, termination and change of use)
 - Renewal of tenancy or lease
 - Use of property (change of use, use as a registered address)
 - Lease assignment (assignment, assignment with leaseback to related company and change in ownership)
 - Transfer of tenancy
 - Termination of tenancy
